- Free health check up camps, medical camps, adoption of villages and slums for upliftment and development.
- Establishing, maintaining, administering, developing, improving, educational institutions like schools, colleges, polytechnic, medical, ayurvedic, clinical, research, vocational training centers, research centers, Adult Education centers etc; Extending grant, donating or and to aid educational establishments; maintenance, improvement and extension of hostels and boarding homes for students pursuing their studies; instituting studentship, scholarships, stipends, medals, prizes etc., to help and encourage deserving students; to provide monetary aid to students, scholars and teachers for pursuing their education; Establishing, maintaining and improving laboratories, libraries and facilities of providing books to the students, teachers, scholars and the like, for their education, donating for purchase of books, information media etc; to organize, hold and conduct lectures, seminars, symposiums etc.,
- the required number of community halls, rest houses, rehabilitation centers, orphanages, hospitals, old age homes by construction or by purchasing or by taking on lease or otherwise;






3.3 MEDICAL:

- 3.5 The income derived and the property acquired for the society shall be applied solely for the promotion of the aims and objects of the Trust as set forth above to all persons irrespective of nationality, community, caste, creed, color, religion, and sex and for the payments of remuneration to any Officer or employee of the Trust or any other persons in consideration of any service rendered to the Trust and no portion of it shall be distributed by way of dividends, profit etc., to the trustees.

4. CONSTITUTION AND MANAGEMENT OF THE TRUST:

- 4.1 The Trust shall be managed and administered with reference to the true spirit of achieving its aims and objects.
- 4.2 The Trust shall be managed by the Founder trustees who constitutes "BOARD OF TRUSTEES" through the managing committee. The Managing Committee shall be constituted by the Board of Trustees, Main Trustee and/or any others trustees appointed from time to time as per the provisions of Clause 5.1 of this Trust Deed.
- 4.3 The Managing Committee consists of the Chairman, Vice Chairman Secretary, Joint Secretary, Treasurer and Joint Treasurer. The Founder Trustee shall be the Chairman of the Trust for his life or till he voluntarily resigns. Thereafter any person designated by the Founder Trustee shall become the Managing trustee for their life or till they resign. The term of the Managing Committee is three years during the first term and five years during the subsequent terms or till the new Managing Committee is appointed by the Founder Trustee/Managing Trustee.
- 4.4 The Managing Committee shall act as per the guidelines/directions issued by the Founder Trustee from time to time.

5. POWERS, DUTIES AND LIABILITIES OF THE TRUSTEES:

- 5.1 The Board of trustees shall be entitled to appoint, by unanimous decision, additional trustees who are likely to contribute to the objectives of Trust and coordinate in carrying out the aims and objects of the Trust, provided however, the total number of Trustees including the Founder Trustee, shall not exceed Ten. If however, the Managing Committee deem it necessary in the interest of the Trust to increase the number of Trustees to more than Twenty, the same shall be increased to such number as they deem it necessary by a Special General Body of the Trust.

6.3 In cases of urgency, the Chairman shall be entitled to, without holding a meeting, circulate the matter to the Trustees for the opinion of each of them and the opinion of the majority in support of a proposition circulated shall be deemed to be Resolution of the Managing Committee.

6.4 The Meeting of the Managing Committee shall be held at the registered office of the Trust or at any other suitable place as decided by the Managing Committee from time to time.
